## **SEMESTER IN REVIEW**

UGA's Land Conservation Clinic assists conservation efforts around the state

During the Spring 2025 semester, UGA's School of Law Land Conservation Clinic welcomed fourteen students (eight law students, five Master's in Ecology students, and one Master of Landscape Architecture student) who served eight clients from across Georgia, including regional nonprofits, local land trusts, and local government staff. From legal research to site visits, this semester's students supported their clients' goals and addressed client requests while expanding their knowledge of conservation law, science, and practice.

In Spring 2025, Land Conservation Clinic students:

- Drafted conservation easements that will protect over 600 acres in South Georgia.
- Completed publications on wetlands protection (Local Wetlands Protection Primer) and the condemnation process (Condemnation FAQ for Land Trusts).
- Assisted a land trust client with annual monitoring, and inventoried conserved properties, collecting data on habitat types, watershed, and conservation purposes to create a story map illustrating the impact of the client's work.
- Reviewed state conservation land bank programs that fund permanent land conservation and drafted a statute to establish a Georgia prototype.
- Created a template conservation easement that provides for the creation and use of a public bike trail.
- Drafted a single tract trail easement, designed to minimize impact to the landowner's land while supporting alternative transportation efforts.
- Provided an overview of federal and state scenic river programs, with a focus on river and land protection.
- Researched whether the state attorney general has the ability to enforce conservation easements.
- Drafted a memorandum of understanding to support neighbor agencies efforts to eradicate invasive species.
